

# Nonprofit Management Graduate Certificate

The objective of our Graduate Certificate in Nonprofit Management is to prepare you for leadership positions in nonprofit and philanthropic (grant making) organizations. The curriculum, which centers on technical skills specific to the nonprofit and philanthropic sectors, is designed to develop the skills necessary to manage and lead financially stable, innovative, and effective organizations.

Opportunities for nonprofit managers with specialized skills have expanded sharply. Currently, approximately 8% of the U.S. total employment is in the nonprofit sector. Recent graduates serve in all nonprofit sectors in a variety of leadership positions.

## Program Learning Outcomes

Upon successful completion of this program, students will be able to:

- Develop and steward nonprofit financial and human resources.
- Ethically manage, govern, and lead nonprofit and philanthropic organizations.
- Synthesize foundational concepts and theories in nonprofit management and leadership.
- Apply learned competencies to real-world nonprofit sector challenges.

## Graduate Certificate in Nonprofit Management Requirements

The graduate certificate in nonprofit management prepares students for leadership in the nonprofit sector. The focused curriculum develops specific skills that are critical for success in managing nonprofit organizations.

Phenomenal growth in assets and activities of the nonprofit sector over the past two decades have led to career opportunities in the many areas of the nonprofit sector, including cultural and arts organizations, education, health care, human services, international development, and advocacy organizations. Nonprofit enterprise has broadened with developing sources of funding, and the complexities of its management require professional skills specific to the nonprofit sector.
